INVITATION TO BID

1 Client: Municipality of Cajetina, Kralja Aleksandra Street, 28 Cajetina, as the beneficiary of thep budget funds. Internet address of the contracting authority: www.cajetina.org.rs

Responsible person of the orderer is the Mayor.

2 The type of public procurement: the open procedure.

3 The legal basis for the publication of the invitation is an Article 60 of Law on Public Procurement ("Official Gazette of RS", No. 124/12), Decision of the Assembly of CAJETINA on the loans, number 02-34/2013-01 of April 4th 2013, the opinion of the Ministry of Finance and Economy, Department for the Public Debt number 401-554/2013-001 of April 9th 2013 and Decision of the Mayor of the Municipality of Cajetina on the public procurement of financial services of loan for the construction of the gondola number 404-37/13-02 of April 11th 2013.

4 The subject of the public procurement: loan for construction of gondola, amounting to 320.000.000,00 RSD, in euros, according to the average rate of the National Bank of Serbia on the exact date of releasing the loan. The deadline for loan repayment is 10 years, with grace period of 24 months included, in monthly installments. The orderer intends to use the loan for financing the procurement and delivery of mechanical and electric equipment and accompanying technical works and providing expert assistance for one new detachable gondola lift with two loops of cable, one intermediate station, one drive machinery undergrounded, with provisory capacity of 600 people per hour and final capacity of 1000 people per hour.

Designation from the general dictionary of public procurements is 6611300-services of loan approval.

5 The right to participate in this procurement procedure has the bidder who meets the mandatory requirements of Article 75 Paragraph 1 Law on Public Procurement. Compliance with the requirements of Article 75 Paragraph 1 Law on Public Procurement bidder proves through

submitting the evidence to prove compliance with Article 77 Paragraph 1 PPL and tender documents.

6. Criteria for selection of the best bid and the award of public procurement contracts is the lowest price of the offered loan. Price of the loan is the effective interest rate, which is calculated in accordance with the decision of the National Bank of Serbia on its calculation.

7 How to download the tender documents and the Internet address:

Tender documents can be obtained directly in the Local Government building in Cajetina, Kralja Aleksandra Street, 28, office No. 213 every day from 8.00am to 3.00pm until the deadline for submission of bids.

8 The method of submission of bids and the deadline:

Bids shall be submitted in person or by mail to the Municipal Administration of Cajetina, Kralja Aleksandra Street, 28, in a sealed envelope marked - Tender for Procurement of service of providing credit for gondola construction, public procurement number 72/13- not to be opened. On the back of the envelope the name, address and telephone of bidder's contact person has to be stated.

Bidder may submit only one bid. The bidder who has already submitted a bid may not simultaneously participate in a joint offer or as a subcontractor, or participate in more joint bids.

During the deadline for submitting the bids the bidder may alter, amend or revoke its offer in the manner specified in the tender documentation.

The deadline for submission of the offer is 30th day from the date of publication of this Invitation in the Official Gazette of RS, and until 12.00 am regardless of the method of delivery.

If the deadline falls on a non-working day deadline for submission of bids shall be the first business day at 12:00 hours.

Bids received after the deadline for submission of bids shall be considered untimely. Late bids will not be opened and after the procedure, they will be returned to the bidder, stating that the offer is untimely.

9 Place, time and manner of opening: Public opening of bids will carry out the commission for the providing the loan, on the last day of the period for submission of bids, at 12.30 am at the premises of the Municipal Government building in Cajetina, Kralja Aleksandra Street, 28, in a Meeting room, on the 2nd floor, in the presence of authorized representatives of bidders.

10. The Conditions for participation of the bidder in the bid opening: Representatives of the bidders are obliged, before the tender opening, to procure delivery of the power of attorney to participate in the bid opening to the commission for public procurement. The power of attorney shall be submitted in written form and it must be filed with at the bidder's, stamped and signed by an authorized representative of the bidder.

11. The deadline for making a decision on the award of the contract is 25 days from the date of opening.

12. The customer may, within the period provided for the submission of bids, make changes or additions to the Bidding Documents and he is obliged to promptly amend or supplement the bidding documents on

the portal of public procurements and on its website.

In the situation when the customer changes or amends to the tender documents eight or fewer days before the deadline for submission of bids, the customer shall extend the deadline for submission of bids and publish notice of the extension of the deadline for submission of bids.

13 The contracting authority shall decide on the suspension of the public procurement procedure if the conditions for the award of the contract are not fulfilled. The customer reserves the right to suspend the procurement in case of objective and verifiable reasons according to Article 109 Law on Public Procurement. Customer will explain in written the decision on termination of the public procurement procedure and submit it to the bidders within 3 days of the decision date.
